Applications are subject to approval by the Yadkin Valley Wine Festival Committee. No vendor sharing or sublet without prior approval. All sales and solicitations must be confined to your assigned booth. Friday set-up from 12noon to 4pm by appointment. Setup begins at 7a.m. Saturday. Setup must be complete and all vehicles must be removed to designated parking area by 10am. Vendors must remain on site until 5pm on Saturday.

**NOTE: All leftover food from this event must be removed, and may not be disposed of in onsite trash receptacles. A certificate of general liability insurance of at least \$1 million naming the Yadkin Valley Chamber of Commerce and the Town of Elkin as additional insured for May 15-17, 2020 must be provided to the Chamber upon acceptance of this application.**
